It is highly recommended that the online learning is completed on a PC or Mac, using Google Chrome, Microsoft Edge, Apple Safari, or Mozilla Firefox as your browser.

Once the online learning section is complete, the link will provide you a certificate showing that you completed the section. Make sure you save an image of that

certificate on your phone or print the certificate out. The online learning section of the class must be completed prior to attending the classroom demonstrations.

**The online learning section must be completed prior to the first day of training. Students who do not provide their certification may be bumped to a future class.**

## **Step 2: Show-Up**

Dates and times for your class are sent at the time of online booking. Please follow that schedule, and reach out if there are any questions or if a course may need to be moved.

**\*\*\*Lifeguard students in Las Vegas will be provided the location of their aquatic session prior to their first class. In the event that the first day of class is the aquatic session, students will be notified by email.\*\*\***

Upon arriving to the classroom demonstration, you will have to present three items to the instructor:

1. Photo Identification verifying you are at least 15 years old. This can be one of the following:
  - A state issued ID, such as a driver's license.
  - A federally issued ID, such as a passport.
  - A combination of a School ID and birth certificate.
2. Certificate of completion for the online learning section. This can be one of the following:
  - Printed copy.
  - Screenshot saved to a mobile device.
  - Emailed PDF to [hmsafety@outlook.com](mailto:hmsafety@outlook.com)

3. Method of payment (if course was not paid in advance).
  - Cash (\$USD)
  - Credit, Debit, or PayPal for in person digital payments.
  - Instructor will verify all payments for prepaid courses.

***Failure to provide any of the above items will result in the student being bumped to a future class.***

## **Step 3: Demonstrate Your Competency**

Students will spend their classroom time reviewing concepts from the online learning section and demonstrating competency in a hands-on environment. This includes lecture, videos, demonstrations, and critical thinking exercises.

***Students are to demonstrate competency in all areas in order to pass the class and receive their certification. Students who do not show competency in all areas will be bumped to a future class.***

## **Step 4: Receive Your Certification**

Students who complete the online course and their classroom session will receive their two (2) year certification through the American Red Cross. Students will receive their certification via email, and it will be sent to the email associated with the online learning assignments.

## **HM Safety Certifications Code of Conduct**

We strive to be a safe, professional, and enjoyable learning environment where students can learn effectively. As such, we do have a few ground rules:

- There are no refunds for the class. If you are removed from the class due to attendance or performance, then you will be bumped to a future class to complete your training. However, students removed from the class due to conduct will not be allowed to return.
